## What do we use your personal information for?

The personal information we obtain from you is used for the following purposes, and is necessary to provide the service in question:

- Information on changes by the SAT, SCT and other authorities
- Compliance with obligations
- Assessment of service quality

## What personal details do we use for these purposes?

For the purposes set out in this privacy notice, we will use the following personal information:

## How can you access, rectify or cancel your personal information, or object to use thereof?

You have the right to know what personal information we have of yours, what it is used for and the conditions for use thereof (Access). Moreover, you are entitled to request that corrections be made to your personal information, in the event it is not up to date, inaccurate or incomplete (Rectification); that we remove it from our records or databases if you consider it is not being used adequately (Cancellation); and object to use thereof for specific purposes (Objection). These rights are known as ARCO rights.

In order to exercise any of your ARCO rights, you must make your request through the following means:

Request in writing or via email.

Following are the steps to be followed to obtain further information on the procedure and requirements for exercising ARCO rights:

Request in writing or via email, containing at the least the following information: (a) name and address, or other means for communicating a reply to the request; (b) documentation accrediting the requesting party's identity, or legal representation thereof; (c) a clear and accurate description of the personal information with regard to which you wish to exercise ARCO rights; (d) express statement to revoke consent to treatment of the personal information in question and therefore, for said information to no longer be used; (e) any other element that will help to locate the personal information in question.
